Registration criteria

A diploma can be registered in the register of formal higher education qualifications:

- if it is a final higher education diploma, awarded after successful completion of a full study cycle;

- if it was obtained in accordance with the laws and regulations regarding the higher education system in the country where it was awarded. Diplomas that do not confer academic degrees recognised by the competent authorities in the country of issuance can not be registered.

Please note that the registration of formal higher education qualifications represents the academic recognition procedure for foreign higher education diplomas, although without conferring a right to practice a regulated profession. It confers the right to use the academic title.
